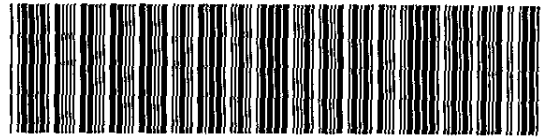

**ARTICLES OF INCORPORATION  
OF  
WILLIAM RAY, INC.**

THE UNDERSIGNED incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I – Name**

The name of the corporation shall be WILLIAM RAY, INC. (hereinafter referred to as “the corporation.”)

**ARTICLE II – Principal Office**

The principal place of business and mailing address of the corporation shall be 178 SW Irwin Avenue, West Melbourne, Florida 32904.

**ARTICLE III – Purpose**

The corporation may engage in any activity or business permitted under the laws of the State of Florida.

**ARTICLE IV – Term of Existence**

The term of existence of this corporation shall be perpetual.

**ARTICLE V – Shares of Stock**

The number of shares that the corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having a par value of one dollar (\$1.00). The consideration to be paid for each share of stock shall be determined by the Board of Directors.

**ARTICLE VI – Board of Directors**

The initial Board of Directors shall be appointed by the incorporator. Any changes concerning the number of directors making up the Board of Directors and the qualification of individuals, corporations, and other entities to be directors shall be provided for in the Bylaws, as amended.

**ARTICLE VII – Officers**

The general officers of the corporation may be the President, Vice-President, Secretary, and Treasurer. The principal duties of each officer shall be prescribed in the Bylaws of

the corporation, as amended. Any changes concerning the qualifications of the persons entitled to be officers, and the manner in which officers shall be elected or appointed, shall be provided for in the Bylaws, as amended. The initial officers of the corporation shall be:

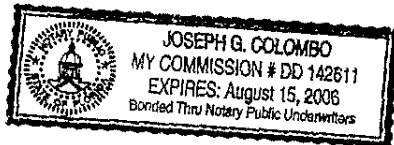
