We would appreciate the State's consideration of the mitigating factors that resulted in our being late in complying with the reporting and fee requirements.

Our physical and mailing addresses changed in 2004 (See enclosed copy of internal letter regarding this change). While we have no documentation to substantiate this claim subsequent correspondence indicated that the we had sent address changes to other correspondents.

Of greater significance is the disruption of the normal business routines of our firm. Significant hurricane damage was suffered at 8127 Pompano Street where much of our administrative work is accomplished. In each of three hurricane disasters we were forced to move files to safer locations.

Another cause of our not being alert to the report due date was our need to defer Semmes, Inc. business plans because of the changing and a bit uncertain real estate market.

We have taken the steps to ensure that this report will be made timely in the future.
