

ARTICLES OF INCORPORATION OF

CENTRAL MEDICAL, INC.

ARTICLE

The name of this corporation shall be CENTRAL MEDICAL, INC., and its principal address is 10453 Tecoma Drive, New Port Richey, FL 34655.

ARTICLE II

This corporation shall have perpetual existence which shall commence at the time of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III

The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, <u>Florida Statutes</u>. The corporation shall also have all other powers provided in the statutes of the State of Florida.

ARTICLE IV

The corporation is authorized to issue 1000 shares of common stock at a par value of \$1.00 per share.

ARTICLE Y

The amount of capital with which this corporation shall begin business shall be not less than \$100.00.

ARTICLE VI

The initial registered agent for this corporation is **Joseph Marchiselli**, and the initial registered office is located at 10453 Tecoma Drive, New Port Richey, FL 34655.

ARTICLE VII

The number of Directors constituting the initial Board of Directors shall be one (1). The number of Directors may be either increased or decreased from time to time as provided for in the By-Laws.

ARTICLE VIII

They shall hold office until the first annual meeting of stockholders.

ARTICLE IX

ARTICLE X

Subject to the provisions of the <u>Florida Statutes</u>, stockholders' meetings may be held at any place designated by the Directors.

ARTICLE XI

The following additional provisions are inserted for the conduct of the affairs of the corporation:

- (a) The corporation may incur any indebtedness in any amount which is in the best interest of the corporation.
- (b) The Board of Directors of the corporation is hereby authorized and empowered, from time to time, at its discretion, to:
 - (i) Make and amend By-Laws of the corporation;
 - (ii) establish such reserves as the Board may deem necessary and in the best interests of the corporation and to set such funds aside for the purpose of the reserve.

The undersigned, constituting all of the original subscribers for the shares of stock of this corporation, and for the purpose of forming a corporation for profit, pursuant to Chapter 607, <u>Florida Statutes</u>, do hereby make and file these Articles of Incorporation, hereby declaring and certifying that the facts stated herein are true and correct.
