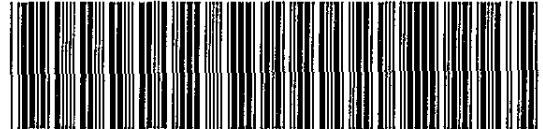

**Articles of Incorporation

The undersigned for the purpose of forming a corporation under the laws of Florida, hereby adopt the following articles of incorporation.

**Article I. Corporate Name**

The name of the corporation is: Cotrans, Inc.

**Article II. Nature of Business and Powers**

The general nature of this business to be transacted by this corporation is to engage in any and all business permitted under law of the State of Florida for providing transport options and broker services for maritime firms.

**Article III. Capital Stock**

If the corporation fails or refuses within such period to make a satisfactory arrangement for the purchase of such shares, the stockholder shall have the right to dispose of his/her shares as he/she may see fit.

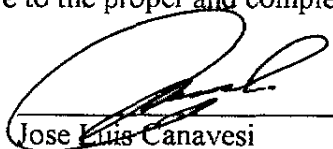
