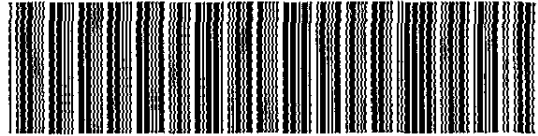

ARTICLE I. NAME
