### ARTICLES OF INCORPORATION

OF

### T&M PROPERTY MANAGEMENT, INC.

The undersigned, acting as incorporator of T&M PROPERTY MANAGEMENT, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

### ARTICLE L NAME

The name of the corporation is T&M PROPERTY MANAGEMENT, INC.
