I incorporated my business on 11/3/03. Because I am very poor, I could not afford an attorney to incorporate me so I incorporated myself and was very unsure of all the proper procedures to become incorporated. I was totally unaware of the corporation annual report filing requirements. I never received a first postcard telling me I had this responsibility. If you sent it to me, it must have been lost in the mail by the post office! If I had received a "first" postcard, I would have handled it promptly. I am now receiving a "second" postcard telling me I was late filing now and this is the first time I knew of any such requirements.
