SECRETARY OF STATE The undersigned hereby makes and subscribes to these these Incorporation intending to form a corporation under the provisions of the Florida Statutes.

ARTICLE I

The name of this corporation is ZINK CONSTRUCTION CARPENTRY, INC.

ARTICLE II

The corporation may engage in the business of providing construction and carpentry to general public and any other activity or business permitted under the laws of the United States and of the State of Florida. While engaging in such activity or business, it may exercise all of the powers and privileges conferred by the Florida General Corporation Act as presently in effect and as it may be amended from time to time in the future.


