

ARTICLE I. NAME

The name of this corporation is STRUCTURED CONCEPTS INC.

ARTICLE II, DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

ARTICLE IV. CAPITAL STOCK
