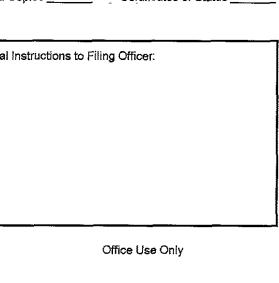

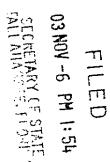
ARTICLE I - NAME
