

ARTICLE I

NAME

The name of the Corporation is LUIS A. MORA TRIM/CARPENTRY,  
INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on  
the date of this filing of these Articles with the Department of  
State.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transacting

ARTICLE IV

CAPITAL STOCK

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.




