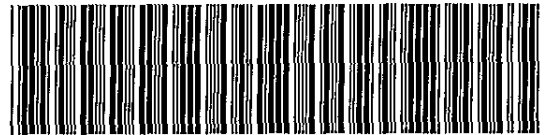

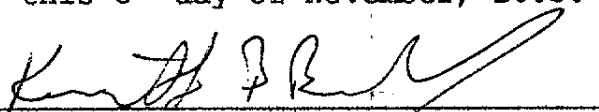
ARTICLE IX
