ARTICLES OF INCORPORATION

OF

RTR INNOVATIONS, INC.

**ARTICLE I
NAME**

The name of the corporation is RTR INNOVATIONS, INC.. The mailing address of the corporation is 1105 Ballinger Road, Lutz, Florida 33548 and the principal address of the corporation is the same.

**ARTICLE II
DURATION**

The Corporation shall have perpetual existence.

**ARTICLE III
PURPOSE**

The Corporation is organized for the following purposes: to engage in the business of developing new products related to the construction industry; to engage in any activity or business incidental to or related to the above purpose; to acquire and hold stock in any corporation; to engage in joint ventures and partnerships, as a limited or general partner; to acquire, own, hold, manage, mortgage, improve, lease, sell, exchange, transfer, and otherwise deal with real, personal, and intangible property wherever situate; to carry out the said purposes in any State, territory, district, or possession of the United States, or in any foreign country; and to engage in any activity or business permitted under the laws of the United States, the State of Florida, and any other State or foreign country.

ARTICLE IV CAPITAL STOCK

The Corporation is authorized to issue 7500 shares of capital stock of the par value of One Dollar (\$1.00) per share which shall be designated "Common Shares", and all of which shall have the same rights and privileges.

ARTICLE V INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial Registered Office of the Corporation is 1105 Ballinger Road, Lutz, Florida 33548, and the name of the initial Registered Agent of the Corporation at that address is Kevin C. Young.

ARTICLE VI INCORPORATOR

ARTICLE VII BYLAWS

The power to adopt, alter, amend or repeal the Bylaws shall be vested in the Board of Directors and the shareholders.


ARTICLE VIII INDEMNIFICATION
