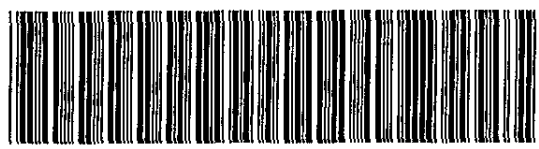

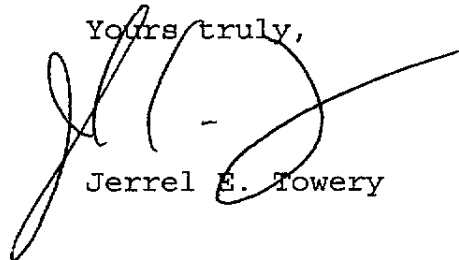

IN WITNESS WHEREOF, I the undersigned, has executed these Articles of Amendment this 31st day of August, 2004.

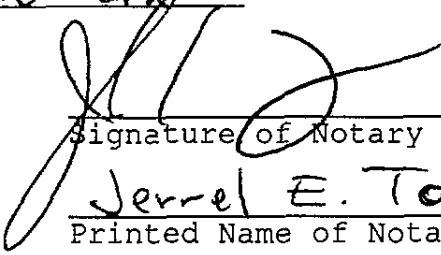
