

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: BILL DORR FENCE INSTALLATION, INC. The principal place of business will be 3928 Haines Rd., St. Petersburg, FL 33703-5628.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE
