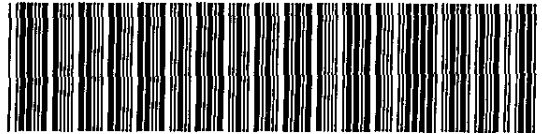



ARTICLES OF INCORPORATION

OF —

ALL TOP GRANITE, INC.

ARTICLE I

The name of this Corporation is: All Top Granite, Inc.

ARTICLE II

This Corporation is organized for the purpose of transacting any and all business for which corporations may be formed under Chapter 607 of the Florida Statutes.

ARTICLE III

This Corporation is authorized to issue 1,000 shares of common stock, no par value.

association or corporation in which he may be anywise interested. Any director of this Corporation may vote upon any contract or other transaction between this Corporation and any firm, association or corporation in which he may be anywise interested.


