AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE INJURY LAW OFFICES OF JOHN T. KENNEDY, P.A.

Pursuant to the provisions of Section 607.1006, Florida Statutes, the Articles of Incorporation of the above-named corporation (the "Corporation"), filed with the Department of State with an effective date of January 1, 2004, and assigned Charter Number P03000127927, are hereby amended pursuant to a written consent in lieu of meeting executed by the holders of all of the Corporation's Common Stock and all of the Corporation's Directors on April 1, 2004, as follows:

ARTICLE I

ARTICLE II

Article 7 of the Articles of Incorporation is hereby amended to read as follows:
