**ARTICLES OF INCORPORATION
OF
BAY AREA TRAVEL ACQUISITION OF SANFORD, INC.**

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
CORPORATE NAME AND PRINCIPAL OFFICE**

The name of this corporation is BAY AREA TRAVEL ACQUISITION OF SANFORD, INC. (the "Corporation") and its principal office and mailing address is 1511 N. Westshore Boulevard, Suite 250, Tampa, Florida 33607.

**ARTICLE II
COMMENCEMENT OF CORPORATE EXISTENCE**

The Corporation shall commence its existence on November 4, 2003.

GENERAL NATURE OF BUSINESS**

BY-LAWS


