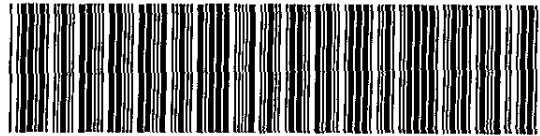

**ARTICLES OF INCORPORATION  
OF  
GOLOBISH FREIGHT SERVICES INC.**

The undersigned, for the purpose of forming a corporation for profit under the Florida General corporation act, do hereby adopt the following articles of incorporation.

**ARTICLE I**

**Golobish Freight Services Inc.**

**The name of the corporation shall be:  
GOLOBISH FREIGHT SERVICES INC.**

**ARTICLE II**

**DURATION**

The corporation shall have perpetual existence with an effective commencement date of November 1<sup>st</sup> 2003.

**ARTICLE III**

**PURPOSE**

The general purposes for which the corporation is organized are:

1. To engage in the business of commodity transport trucking service.
2. To transact any other lawful business activity for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE IV**

**REGISTERED OFFICE AND REGISTERED AGENT**






**STATEMENT ACCEPTING APPOINTMENT AS REGISTERED AGENT**
