ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF RONMIL, INC.



Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of RONMIL, Inc. (the "Corporation") are hereby amended according to theses Articles of Amendment:

FIRST:

The name of the Corporation is RONMIL, Inc.

SECOND: Article I of the Articles of Incorporation, as amended, is hereby deleted in its entirety and the following inserted in lieu thereof:

"The name of the Corporation is MAYA'S CARPOOL II, INC."

THIRD: The foregoing amendment was adopted by Joint Unanimous Written Consent of the Board of Directors and the Shareholders dated as of November 14, 2003.

FOURTH: Except as hereby amended, the existing Articles of Incorporation of the Corporation shall remain in full force and effect.
