ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is TELESCOPE, INC., and the principal address and principal place of business is 470 2<sup>ND</sup> STREET NORTH, SAFETY HARBOR, FLORIDA 34695.

ARTICLE II - REGISTERED OFFICE AND AGENT
