





## ARTICLES OF INCORPORATION OF NAUTILUS TELECOMMUNICATIONS, INC.

#### ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is NAUTILUS TELECOMMUNICATIONS, INC., and the principal address and principal place of business is 2240 BELLEAIR ROAD, SUITE 160, CLEARWATER, FLORIDA 33764.
