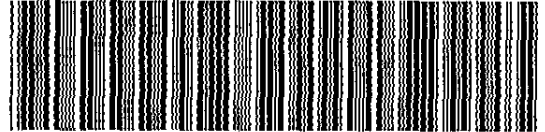

The undersigned natural person of the age of eighteen years or more for the purpose of forming a corporation under Chapter 607 of the Official Florida Statutes, as revised from time to time adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is: TANGO FAUX ART, INC.

The principal office of the Corporation is: 3235 Cypress Glen Way, #304, Naples, FL 34109

ARTICLE TWO

The address including street and number, if any, of the corporation's initial registered office in this state is 3235 Cypress Glen Way, #304, Naples, FL 34109 and the name of its initial agent at such address is Ricardo Trujillo.

This corporation is to have perpetual existence.

The aggregate number, class and par value, if any, of shares which the corporation shall have authority to issue shall be:


100 shares of \$1.00 par value, common voting shares of capital stock and no other class of stock.




DESIGNATION AND ACCEPTANCE OF REGISTERED AGENT
