The undersigned, for the purpose of forming a Corporation under Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND PLACE OF BUSINESS

The name of this Corporation is Losoncy Masonry, Inc. with its principal place of business at 4601 – E 100 Unit 139, Bunnell, Florida 32110.

ARTICLE II

DURATION

This Corporation shall exist perpetually.
