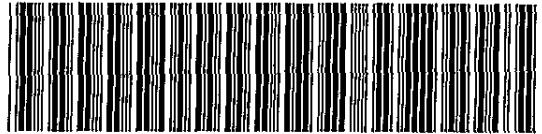

**ARTICLES OF INCORPORATION
OF
MATT'S AMERICAN ENTERPRISES, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be:

MATT'S AMERICAN ENTERPRISES, INC.

The principal place of business of this corporation shall be:

425 W. Church Street, DeLand, FL 32720

ARTICLE II: NATURE OF BUSINESS

This corporation is organized for the purpose of engaging in the business of providing home improvement services and engaging in and transacting any or all other lawful business permitted under the laws of the State of Florida or any other state and of the United States.

ARTICLE III: SHARES

This corporation is authorized to issue one thousand (1,000) shares of common stock having no par value, which shares shall be and hereby are designated as "common shares."
