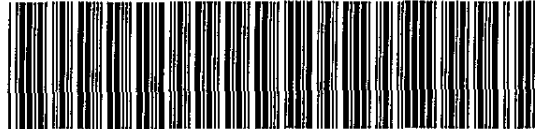

ARTICLE I

NAME

The name of the Corporation is Totally Elite Enterprises Inc.

ARTICLE II

PRINCIPAL OFFICE

ARTICLE III

PURPOSE OF CORPORATION

The purposes for which the business of the Corporation shall be conducted are as follow:

- A. To engage in every phase aspect of the business as determined by the Board of Directors from time to time including, without limitation, the manufacture, design, construction, ownership, use, purchase, sale or lease, of articles and property of all kinds and to render services of all kinds and to engage in any lawful act or activity for which corporations may be organized under the laws of the United States and the State of Florida

The Corporation shall commence on the date these Articles are filed with the Secretary of State, and thereafter shall have perpetual existence unless dissolved according to law.

ARTICLE V

CORPORATION CAPITALIZATION

- A. The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred (100) shares of common stock having a par value of \$.001 per share.

ARTICLE VI

VOTING RIGHTS

Except as otherwise provided by law, the entire power for the election of Directors, and for all other purposes, shall be vested exclusively in the holders of the outstanding shares of common stock.
