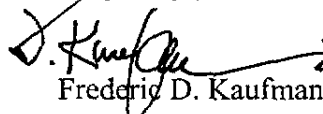

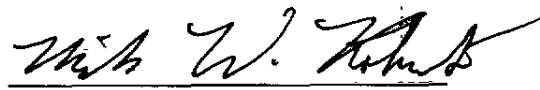
ARTICLES OF INCORPORATION

The undersigned for the purpose of organizing a Florida Profit Corporation adopt the following Articles of Incorporation:

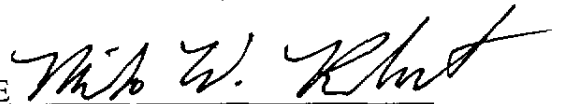
