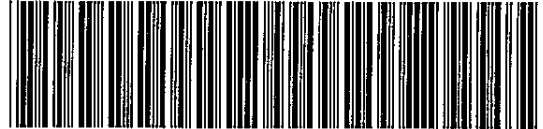

ARTICLE I

The name of this corporation is RED BEAR CONSTRUCTION, INC.

ARTICLE II

This Corporation shall have perpetual existence, unless sooner dissolved according to law.




