To Whom It May Concern:

I would like to request a waiver based on REV. PROC. 98-55 for a late filed 2553 for my corporation, Tropical Pools of Indian River County, Inc. The 2553 was inadvertently filed late due to it being misfiled with license regulations for the State of Florida. I incorporated in order to comply with the new State of Florida workers compensation exemption requirements in November 2003. Upon incorporating, I was required to transfer my business licenses into the corporation, which involved a tremendous amount of paperwork including obtaining credit reports for the corporation and its officers, bank verification letters, financial statements, copies of licenses, and more. The 2553 was inadvertently included as part of all of this paperwork and I did not realize it had not been filed until we were compiling the final documents for the State of Florida. I respectfully request a waiver due to this reasonable cause for late election and permission to file as an S Corporation for the short year of 2003. I have met all other requirements for being an S Corporation and have filed this request before the original filed tax return. I thank you in advance for processing this request.
