

ARTICLES OF INCORPORATION

In compliance with the provisions of Chapter 607, <u>Florida Statutes</u>, the undersigned, for the purpose of forming a corporation, does hereby make, subscribe, acknowledge and file in the office of the Secretary of State of the State of Florida, as the Articles of Incorporation of Lewis & Lewis Painting, Inc., a Florida corporation, the following, to wit:
