Each share of stock issued subject to these Articles shall be endorsed as follows:

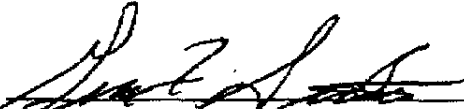

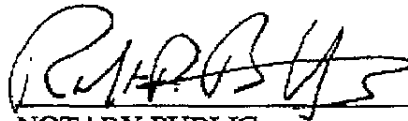

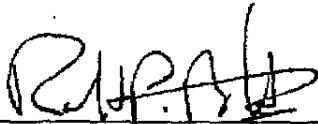
