ARTICLES OF INCORPORATION OF HENRY ROHDE, INC.

THE UNDERSIGNED, acting as sole incorporator of HENRY ROHDE, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:
