Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Corporation does hereby file the following Articles of Amendment:

1. That the name of the Corporation is Steven P. Snow, M.D., P.A.

2. That Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I
CORPORATE NAME


