ARTICLES OF INCORPORATION FOR SHAE SOLUTIONS GROUP, INC.

The undersigned incorporator of these Articles of Incorporation, being a natural person competent to contract, hereby presents these Articles of Incorporation to the Secretary of State for the State of Florida for the formation of a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is Shae Solutions Group, Inc.

ARTICLE II

The general nature of the business to be transacted by this corporation shall be:

- A. To transact any lawful business for which corporations may be formed under the laws of the State of Florida;
- B. To invest the funds of this corporation in real estate; mortgages; stocks; bonds; or any other type of investment, and to own real and personal property necessary for the operation of the business.

ARTICLE III

- This corporation is to have perpetual existence.
- B. The corporate existence of this corporation shall commence five (5) days prior to the date of filing hereof.
