## ARTICLES OF INCORPORATION OF

## PROGRESSIVE ORTHODONTICS, P.A. (a Professional Association)

The undersigned, JOEL STOLZENBERG, acting as Incorporator of a Florida Corporation under the Professional Service Corporations Act, Chapter 621 of the Florida Statutes and the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation.

#### ARTICLE I

#### **NAME**

The name of the Professional Association is PROGRESSIVE ORTHODONTICS, P.A.

#### ARTICLE II

#### PRINCIPAL OFFICE

The principal place of business and mailing address of this Professional Association shall be: 1701 Highway AIA, Suite 220, Vero Beach, Florida 32963.

#### ARTICLE III

#### PURPOSE
