The undersigned, JOEL STOLZENBERG, acting as Incorporator of a Florida corporation under the Professional Service Corporations Act, Chapter 621 of the Florida Statutes and the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

NAME

The name of the Professional Association is PROGRESSIVE ORTHODONTICS, P.A.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this Professional Association shall be: 1701 Highway A1A, Suite 220, Vero Beach, Florida 32963.

ARTICLE III

PURPOSE

The purpose of the business to be established is for any lawful purpose or purposes of a professional corporation allowed under the Florida Professional Service Corporations Act, Chapter 621 of the Florida Statutes and the Florida General Corporation Act, Chapter 607, Florida Statutes, including but not limited to:

- a. To engage in the practice of dentistry as a professional association and to own and operate a dental office for the purposes of providing dental and orthodontic care and treatment.
- b. To treat, prescribe, diagnose, or operate for any disease, pain, injury, deficiency, deformity or physical condition of human teeth, gums, jaws, and adjacent tissues.

- c. To furnish, construct, reproduce, or repair prosthetic dentures or bridges to be used and worn as substitutes for natural teeth.
- d. To supply, repair, or construct orthodontic or various appliances used for the correction of malocclusion or deformities of other structures.

The purposes of this professional association shall be carried out only through officers, employees, and agents, each of whom is licensed or otherwise legally qualified to render professional dental or orthodontic services in the State of Florida.

ARTICLE IV

CAPITAL STOCK

The Corporation is authorized to issue 100 shares of Common Stock with a par value of \$.001.

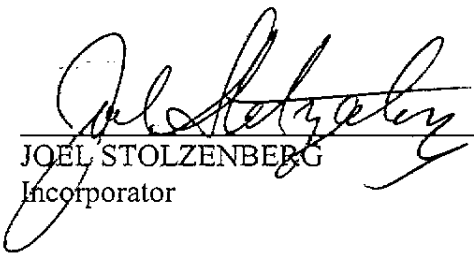

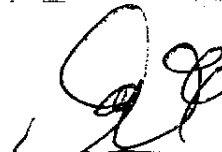
