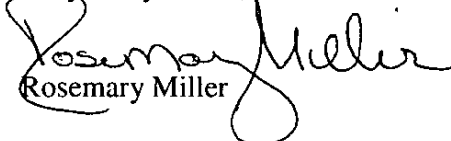
Dear Sir or Madam,

My corporation was dissolved due to nonreceipt of my annual report form for 2004. I have no record of receiving an annual report notice for my company. In the interim, after my company was dissolved, someone else took my company's name, which I think is a terrible miscarriage of justice. Many times the Department of State shows "UA" in its records much longer than a year after a company is dissolved. Your department is inconsistent with its practices, and I have been damaged by your uneven application of rules. You have no idea of the trouble it causes to let others leap into a company name that was only a year old when you gave the name to someone else. Do you have any idea of the mess this causes?

In any event, life goes on. Since I never was sent an annual report notice for 2004, I am enclosing a check for \$450.00 representing the annual report fee for 2004, 2005, and 2006. Additionally, I have enclosed a separate check for a name change amendment in the amount of \$35.00. Please accept these payments as payment in full, as I never received an annual report notice. Please work together with the amendments and reinstatements sections as I realize two departments need to work on this for it to come out right in the end (I must be reinstated and a name change has to be processed, not necessarily in that order I suppose).

Thanks in advance for getting my company back into current status.
