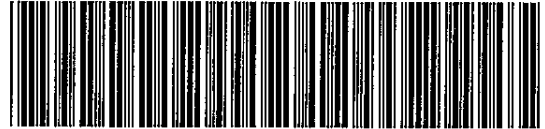

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of general trucking services such as deliveries and pick up and driving all types of trucks for deliveries and pick up to the public and private sector and to transact any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended including but not limited to the general work trucking services.




ARTICLE VIII - INDEMNIFICATION


