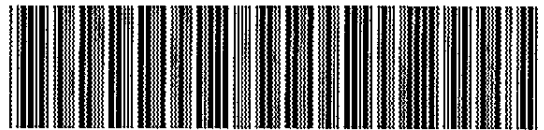

ARTICLE I.

NAME

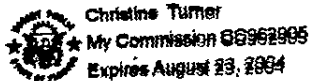


