The undersigned, acting as incorporator of Hispanu Magazine, Inc. under the Florida General Corporation Act, adopts the following Articles of Incorporation.

#### ARTICLE I - NAME

The name of the corporation is:

#### ARTICLE II - COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

### ARTICLE III - PURPOSE

This corporation is formed for the purpose of engaging in the business of printed publications including but not limited to, all businesses incidental thereto and may also engage in any other business and/or activity permitted under the laws of the United States of America and the State of Florida.

#### ARTICLE IV - AUTHORIZED SHARES

The minimum number of shares that the corporation is authorized to have outstanding at any time is 500 (Five Hundred) shares of common stock having a par value of \$1.00 (One US Dollar) per share. The consideration to be paid for each share shall be fixed by the Board of Directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation, which a value, in the judgment of the Directors, equivalent to or greater than the full par value of the shares.

The Articles of Incorporation may be amended prior to the issuance of the shares of the corporation by the unanimous approval or consent of the Board of Directors.
