

The undersigned incorporator, for the purpose of forming a Corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The term of corporate existence shall commence on the date of filing of these Articles with the Department of State, and the Corporation shall have perpetual existence thereafter.
