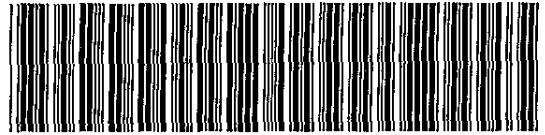

**ARTICLE I**

**NAME**

The name of the corporation shall be **Town & Country Rental Center, Inc.**

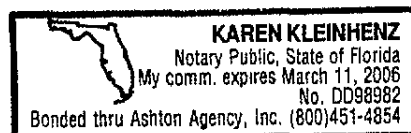


