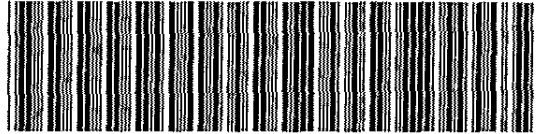



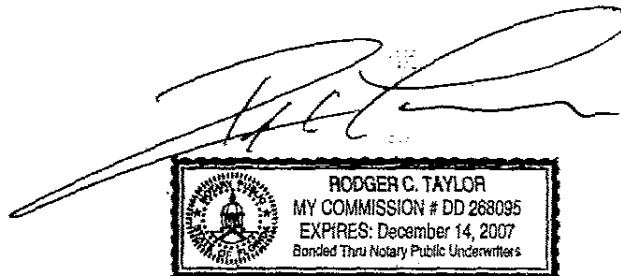

Being a quorum and all of the Directors of the corporation.


Upon motion duly made, seconded and carried, the board of directors proposed to change the name of the corporation to:
