**ARTICLES OF INCORPORATION
OF
ELVIS THOMPSON PAINTING & DESIGNS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the Corporation is **Elvis Thompson Painting & Design, Inc.** (the "Corporation").

- THIRD: The Corporation is authorized to issue 10,000 shares of common stock, par value \$.001 per share.

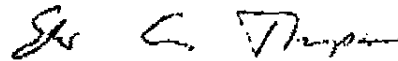
