

ARTICLES OF INCORPORATION

OF

HLA/PJP, INC.

The undersigned incorporator has executed these Articles of Incorporation to establish a corporation (the "Corporation") under the Florida Business Corporation Act (Chapter 607, Florida Statutes).

1. Name. The name of the Corporation is:

2. <u>Principal Office and Mailing Address.</u> The address of the principal office and the mailing address of the Corporation is:
