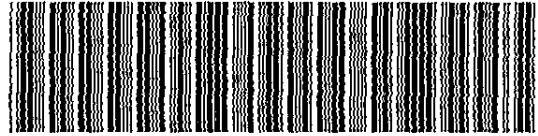





ARTICLE 9: SUB CHAPTER S CORPORATION


This corporation shall elect to become a Sub-Chapter S Corporation as defined by the Internal Revenue Code.


