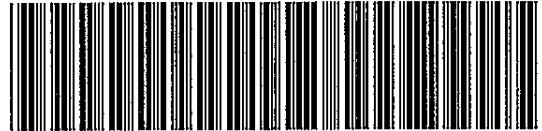

ARTICLE I-NAME

*The name of this corporation is Fultz's Carpentry, Handyman & Painting Service, Inc.*

ARTICLE II-DURATION
