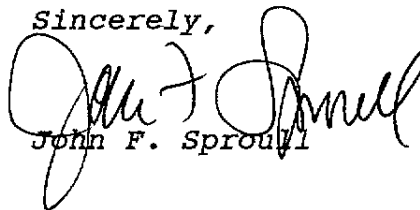

ARTICLES OF INCORPORATION

OF

MIKEY SCOTT LATHING, INC.

ARTICLE I - NAME

The name of the Corporation shall be MIKEY SCOTT LATHING, INC.

ARTICLE II - EXISTENCE

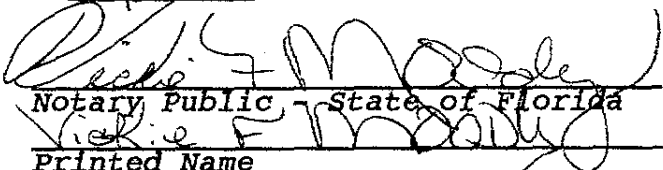
