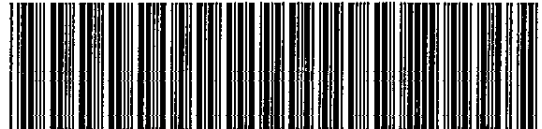

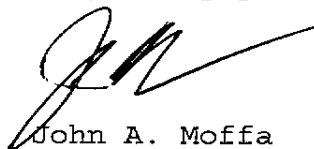

The undersigned subscriber, a natural person competent to contract files these Articles of Incorporation to form a corporation under the laws of the State of Florida

ARTICLE I - Name and Address

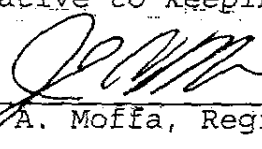
The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the Shareholders.

ARTICLE X - Registered Agent

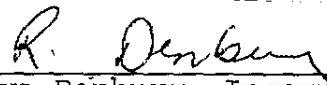

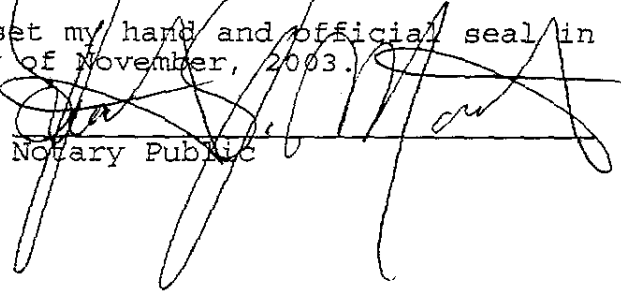
