ARTICLES OF INCORPORATION

STATUS CARPETS & UPHOLSTERY CLEANING SERVICE COMPANY

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filling the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Status Carpets & Uphoistery Cleaning Service Company.

ARTICLE II

The existence of the corporation shall begin on November 14, 2003.

ARTICLE III

The street address and mailing address of the principal office of the Corporation is 1058 Guild Street, Fort Charlotte, Florida 33952.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares.
